Partially Dead Tree at Bishop Pavilion being cut down in next few weeks

Dead Tree at SFA Bust area is being cut down by Texas Department of Transportation

Continuing to work with City in regards to work schedule for Alley Capital Improvement Projects Utility Upgrades – 4th Qtr, 2023

TLD Ramp continues to progress in opening to full capacity its major operations facility in Bellville. TLD Ramp are finalizing plans to double the size of the current site in Bellville and an improved and safer entrance. In addition, TLD Ramp has a possible 3 more companies moving to the Bellville area.

ADA sidewalk grant project with Texas Department of Agriculture is 60% complete. Construction started July 24, 2023 with anticipated completion end of October, 2023

Discussion continuing with 2 possible developers about 40 to 50 room hotel in Bellville. The first step of conducting a Hotel Feasibility Study is moving forward. Feasibility study should be completed by November, 2023 or sooner.

2 possible business development grant applications are in the process of completion and submittal to the BEDC Grant Review Committee.
